giving our exams. All of us would be back to office marching towards GST Audit, VAT Audits etc.



Privileges of Small Company - RAGI.R.NAIR SRO 0595506

2(85) of Companies Act, 2013 "Small company" means a company, other than a public company,—

Paid-up share capital of which does not exceed fifty lakh rupees or such higher amount as may be prescribed which shall not be more than ten crore rupees; AND

Turnover of which as per profit and loss account for the immediately preceding financial year does not exceed two crore rupees or such higher amount as may be prescribed which shall not be more than one hundred crore rupees

Provided that nothing in this clause shall apply to—

- a holding company or a subsidiary company;
- a company registered under section 8;
- a company or body corporate governed by any special Act;

> INTENT BEHIND CARVING OF SMALL COMPANIES

To allow such small companies to operate under relatively lighter regulatory oversight considering the size in which they operate, to facilitate compliance by small companies in an easy and cost effective manner., To ensure small companies do not suffer the consequences of regulation designed to ensure balancing of stakeholders' interests of large, widely held entities.

> PRIVILEGES AND EXEMPTIONS TO SMALL COMPANIES

The Ministry of Corporate Affairs (MCA) through its notification dated 5 June 2015 provided various exemptions to private companies. Further, MCA vide its notification dated 13 June 2017 provided additional exemptions to private companies.

> SIGNING OF ANNUAL RETURN

Annual Return of the Small Company can be signed by the company secretary alone, or where there is no company secretary, by a single director of the company

> MEETINGS OF THE BOARD

A small company may hold only two board meetings in a year i.e one Board Meeting in each half of the calendar year and the gap between the two meetings is not less than ninety days

MANDATORY ROTATION OF AUDITORS AS PER SECTION 139(2)

Small companies are exempted from the requirement from mandatory rotation of auditor as per Section 139(2) of the Act, 2013 read with Rule 5 of the Companies (Audit and Auditors) Rules, 2014

> AMALGAMATION (SECTION 233)

Special provisions has been made in the Act for merger of two or more small companies or between a holding company and its wholly owned subsidiary company or such other class or classes of companies as may be prescribed. This provides for liberal methodology for amalgamation without going to the Tribunal, if the Registrar and the Official Liquidator has no objection or suggestions to the scheme. In such a case, the Central Government shall register the scheme and issue a confirmation thereof.

> FEES FOR SMALL COMPANIES

There is substantial rebate in fees for registration of small companies. It is also provided that such fees will be applicable only if it remains small for a minimum period of one year from the date of its incorporation.

> INTERNAL FINANCIAL CONTROLS

An Auditor of small companies are not required to report on the adequacy of the internal financial controls and its operating effectiveness in the auditor's report.

> CONSOLIDATEDFINANCIAL STATEMENTS

As Per S. 129 (3), it appears that small companies are not required to prepare consolidated financial statements. But, the small companies which have an associate company or joint venture have to prepare the consolidated financial statements.

A small company need not remain a small company throughout its existence. The year it fails to meet the essential requirements as mentioned earlier, the benefits will be withdrawn from next year onwards. The Act facilitates business-friendly regulations for the small companies and is a positive step taken towards promoting investments and small companies.
